- 1. Voting members are Individual SAIS members with the CSb(SA) designation, Honorary members and Corporate members.
- 2. Only members in good standing will be eligible to submit their votes.
- 3. The percentage vote necessary to carry an ordinary resolution shall be 50% of the votes received from members in good standing.
- 4. The percentage vote necessary to carry the special resolution for amendment of the Constitution shall be 75% of the votes received from members in good standing.
